PVC FENCE, TEXTILES AND MORE

Limited Lifetime Vinyl Fencing Warranty

Upon proper product maintenance by the registered purchaser and with normal use, CAN Supply Wholesale Ltd. warrants that its vinyl fencing products will be free from material defects such as rot, rust, splitting, flaking, peeling, blistering, abnormal weathering or abnormal discoloration. Tan or other non-white product warranty does not include normal color fade due to weather and sunlight.

The warranty automatically ends upon the death of the last registered homeowner(s) or if there is a sale of the property. The warranty can be transferred one time from the original registered homeowner to the new owners of the property with the following limitations: new homeowner must obtain an original or copy of the original sales receipt (with proof of date) from the previous owner(s); if fence is purchased from a builder or installer, documentation must be supplied that names the product installed on property and date of transfer.

CAN Supply Wholesale Ltd. will have the option to repair, replace or refund (original amount paid) any fencing supply, in the event of a defect in the product, whereby the registered purchaser is still residing and maintaining ownership of the property.

CAN Supply Wholesale Ltd. will be responsible solely for the expenses of the repair, replacement or refund of the fencing product and not liable for anything beyond this including labor, removal, installation costs etc.

The original and remaining warranty period will be applied to all repaired or replacement materials, not extended.

A warranty period of 30 years will be applied to all fencing supply purchasers who are not individual homeowners residing on the property, such as the following; corporations, government agencies, apartment buildings, schools etc.

Limitations of Warranty

The CAN Supply Wholesale Ltd. warranty does not provide protection against any failure, defect or damage caused by situations and events beyond normal exposure conditions, including but not limited to the following:

- Misuse, abuse, neglect or improper handling or storage;
- Improper service and installation;

- Use of additional materials/accessories that are not compatible with CAN Supply Wholesale Ltd. fencing supplies;
- Impact of foreign objects, fire, earthquake, flood, lightning, hail, hurricane, tornado or other casualty or acts of God;
- Movement, distortion, collapse or settling of the ground or structure on which the fence is installed;
- Distortion or melting of the vinyl fencing supplies due to external heat sources, including but not limited to, barbeque grills, fires or as a result of reflection from windows, doors or other objects;
- Any other cause not involving manufacturing defects in the material supplied by CAN Supply Wholesale Ltd.

The fencing supplies are not warranted against discoloration or other damage caused by air pollution (including but not limited to metal oxides or metallic particles), mildew, exposure to harmful chemicals or normal weathering from the elements.

Normal weathering is defined as exposure to sunlight and extremes of weather and atmosphere that will cause any colored surface to gradually fade, chalk or accumulate dirt or stains. The severity of any condition depends on the geographical location of the fence, the cleanliness of the air in the area and many other influences over which CAN Supply Wholesale Ltd. has no control.

CAN Supply Wholesale Ltd. shall have sole discretion to determine whether the fencing is suffering from normal weathering. If the fencing weathers to a degree determined by CAN Supply Wholesale Ltd. to be beyond normal, CAN Supply Wholesale Ltd. will either repair, replace or refund (original purchase amount, not including the cost of initial installation) for the defective fencing.

Notwithstanding anything set forth above, the fence is warranted against yellowing of the product due to normal weathering from the elements. Material must be maintained following the care and maintenance procedures found at cansupplywholesale.ca.

Lifetime coverage does not apply to fencing product used as common perimeter or common pool fencing. Common perimeter and common pool fencing is covered by a 30-year limited warranty.

This warranty does not apply to and the warranty is voided for fencing product that has been painted, varnished or coated over the manufacturer's original finish.

CAN Supply Wholesale Ltd. reserves the right to discontinue or modify any of its products, including the color, without notice to the homeowner/purchaser, nor shall CAN Supply Wholesale Ltd. be liable in the event the replacement product may vary in color or gloss in comparison to the original product. If CAN Supply Wholesale Ltd. replaces or repairs any product under this warranty, it may substitute products designated by CAN Supply Wholesale Ltd. to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.

Transferability

This limited warranty is transferable one time only by the original registered homeowner(s) residing on the property to the subsequent homeowner(s) where the CAN Supply Wholesale Ltd. fence products were installed, provided that the subsequent homeowner retains the original or a copy of the original bill of sale from the initial registered owner. Lifetime warranty coverage is only available to the original homeowner. In the event of property transfer, the term of this limited warranty will be for a maximum of 30 years from the date of original installation. In the case of fence product purchased by or installed upon property not owned by individual homeowner(s) as their residence, the limited warranty is not transferable. Warranty transfers must be completed within 30 days from the date of title transfer. Transfer requests may be downloaded at www.cansupplywholesale.ca.

Warranty Registration Guideline

The warranty must be registered within 30 days of purchase. Warranty registration forms can be found at www.cansupplywholesale.ca. Once the registration is complete it can be sent to CAN Supply Wholesale Ltd.. Confirmation will be sent that your fence has been registered. In the case of a warranty claim the homeowner/consumer must promptly notify CAN Supply Wholesale Ltd. in writing explaining the deficiency. Also, please provide original invoice, proof of the date of purchase, and proof of property ownership. The consumer may be required to submit a sample of the defective material to CAN Supply Wholesale Ltd. for analysis, freight and any other costs incurred will be at the expense of the customer. CAN Supply Wholesale Ltd. will then investigate the claim and may examine the material claimed to be defective. If a defect covered by this warranty is confirmed, CAN Supply Wholesale Ltd., within a reasonable amount of time after the inspection, will repair or provide replacement material for the fencing or refund the amount paid by the original owner for the fencing and accessories, per the terms of this warranty.

Additional Conditions

This document constitutes the exclusive warranties and remedies provided by CAN Supply Wholesale Ltd.. the warranties and remedies contained in this document are expressly in lieu of any and all other obligations, guarantees and warranties, whether written, oral or implied. CAN Supply Wholesale Ltd.'s obligations, responsibilities and liability shall be limited to repairing, replacing, refunding or cleaning the defective product as set forth in this limited warranty. in no event shall CAN Supply Wholesale Ltd. be liable for any special, indirect, incidental or consequential damages of any kind, including any damage to the property, the building or its contents or for injury to any persons, that may occur as a result of the use of CAN Supply Wholesale Ltd. products or as a result of the breach of this warranty. In no event shall CAN Supply Wholesale Ltd. total liability arising out of or related to the product(s) or this warranty exceed the original purchase price of the fence product.
